Please be aware that there may be increased risk to your dog for sickness or injury while they are at camp. You are responsible for any medical costs associated with your dog's stay at Claire's Dog Camp, regardless of the cause. We advise you to purchase pet medical insurance to cover this increased risk.

Owner agrees to pay the rate for boarding in effect as of the earliest of either the date indicated on the accompanying form as "date in" to the Camp or when the Pet is physically delivered to the Camp.

Owner understands and agrees that in admitting the Pet to the Camp, the Owner and staff of the Camp have relied upon Owner's representations that the Pet is in good health and has not harmed or shown aggressive or threatening behavior toward any person or dog.

Owner further agrees to pay all costs and charges for special services requested, and all reasonable veterinary costs needed for the Pet during the time period the Pet is in the care of the Camp.

All charges incurred by Owner shall be payable upon pick-up of Pet, or when billed by the Camp at address listed on the accompanying form. The Camp shall have, and is hereby granted, a lien on the Pet for any and all unpaid charges resulting from boarding said Pet at the Camp. The Owner hereby agrees that in the event the boarding charges are not paid when due in accordance with this contract, the Camp may exercise its lien rights upon twenty days written notice given by the Camp to private or public sale, in the sole discretion of the Camp, and Owner specifically waives all statutory or legal rights to the contrary. If such sale shall not secure a price adequate to pay such costs of board or other charges delinquent, plus costs of sale, then Owner shall be liable to the Camp for the difference. All monies realized by the Camp at such sale, over and above the charges due the camp shall be paid by the Camp to the Owner.

The Owner hereby agrees and acknowledges that any fee which may have been paid to the Camp in connection with the Camp's acceptance of the Pet pursuant to this Agreement is not refundable.

Owner further agrees that the Pet shall not leave the Camp until all charges are paid to the Camp by Owner.

By signing this Agreement and leaving their Pet with the Camp, Owner certifies the accuracy of all information given about said Pet.

Owner specifically represents to the Camp that the Pet has not been exposed to rabies or distemper within a thirty-day (30 day) period prior to boarding.

The Camp shall exercise reasonable care for the Pet delivered by the Owner to boarding at the Camp. It is expressly agreed by the Owner and the Camp that the Camp's liability shall in no event exceed the lesser of the current chattel value of a Pet of the same species. The Owner further agrees to be solely responsible for any and all acts or behavior of said Pet while it is under the care of the Camp.

Owner understands and agrees that any problems which develop with the Pet will be treated as deemed best by the Owner, or in the event that the Owner cannot be contacted, in the event of an emergency, at the sole discretion of the Camp and that Owner will assume full financial responsibility for any and all expenses.

If the Pet becomes ill or if the state of the animal's health otherwise requires professional attention, the Camp, in its sole discretion, unless otherwise specifically directed, may engage the services of a local veterinarian or administer medicine or give other requisite attention to the Pet and the expenses thereof shall be paid by Owner.

Owner understands and agrees that the Pet will be sharing space with other dogs and that dogs may at times get into conflicts and possibly biting situations. These situations may or may not be witnessed by the Owner or staff at the exact time of occurrence. The Owner and staff of the Camp will make their best effort to avoid situations, however, Owner understands that all events cannot be anticipated or avoided. Owner hereby releases the staff of the Camp from any liability should such events occur.

Owner understands and agrees that he/she is solely responsible for any harm caused by the Pet while the Pet is sharing space with other dogs in the facility. If Owner's dog is witnessed or suspected of causing harm to another dog or person, they may be removed from the daycare yard and prevented from sharing space with other dogs in the facility. Every effort will be made to make other accommodations for the Pet.

Owner understands and agrees that the Camp will not be liable for any problems or injuries that develop between dogs while sharing space at the Camp. Owner hereby releases the Camp and all of its staff of any liability of any kind arising from the Pet's attendance and participation in shared space at the Camp. Further, Owner hereby agrees to indemnify, defend and hold harmless the Camp and any of its staff from any loss, claim, injury, liability, fee or expense incurred while the Pet participates in shared space at the Camp.

Owner hereby agrees to waive any claims, complaints, or causes of action whatsoever, whether in law or equity, against the Camp, its owners or any other agents and hereby agrees to indemnify and hold harmless the Camp for any loss, damage or injury or expense arising in any manner including, but not limited to any such action of claim arising from this Agreement, the actions of the Pet or any loss of damage to third parties, or property owned by third parties or liability incurred in defending any action by third parties. This release and indemnification shall apply to the Owner, its heirs, executors, beneficiaries or assigns.



Any controversy or claim arising out of or relating to this Contract, or breach thereof, as a result of any claim or controversy involving the alleged negligence by any party to this contract, shall be settled in accordance with the rules of the American Arbitration Association, and judgment upon the award rendered by an arbitrator may be entered in Lamoille County Court. The arbitrator shall, as part of his award, determine an award to the prevailing party of the costs of such arbitration and reasonable attorney's fees to the prevailing party.

The parties agree that Vermont law shall pertain and be applied to interpretation of this Agreement or any alleged breach thereof.

This Contract contains the entire Agreement between the parties. All terms and conditions of this Contract shall be binding on the heirs, administrators, personal representatives and assigns of the Owner and the Camp,
